Chelan County Ordinance: 7.52.015 County road restrictions.*

(a) The board of Chelan County commissioners designates Level 1 road travel restrictions be enforced throughout the unincorporated areas of Chelan County as identified in Exhibit A, as of June 25, 2011, as follows:

(1) Level 1 area activity restrictions include:

(A) No fireworks;

(B) No open flames devices;

(C) No motor vehicles off the roadway;

(D) No outdoor fires except for recreational/home campfire rings installed in accordance with the Chelan County fire advisory board guidelines. "Campfire enclosure" is an outdoor fire burning materials other than rubbish where the fuel being burned is contained within a metal (minimum ten gauge) ring or other approved noncombustible material, not more than thirty-six inches in diameter and not more than seven inches in height above grade and not more than sixteen inches in depth, set in cement (four inches thick) and having all combustible material removed down to mineral soil, and no less than one and one-half feet from the perimeter of the fire ring and filled in with gravel or rock. Fuel for the recreational/home campfire cannot extend above the edge of the campfire enclosure or ring.

OTHER PROHIBITIONS/REQUIREMENTS THAT APPLY TO ALL OURDOOR BURNING

(4) **Unlawful outdoor burning:** It is unlawful for any person to cause or allow outdoor burning that causes an emission of smoke or any other air contaminant that is detrimental to the health, safety, or welfare of any person, that causes damage to property or business, or that causes a nuisance. (RCW [70.94.040](#), [70.94.650](#)(1), and [70.94.780](#))

(a) Any person affected by outdoor burning may file a complaint with the permitting agency or other designated enforcing agency.

(b) Any agency responding to an outdoor burning complaint should attempt to determine if the burning on any particular property is unlawful. This may include, but is not limited to, considering whether the burning has caused an emission of smoke or any other air contaminant in sufficient quantity to be unlawful.

(c) Any person responsible for such unlawful outdoor burning must immediately extinguish the fire.
