



Emergency Response Average and 90% Arrival Times




















Significant Calls in September, 2014 and the not so significant

Vehicle Fire 09/20/2014 around 1258 hours: Chief 701, Rescue 71, Tender 71 responded to a fully involved vehicle fire on the Gorge Road about a mile up from Chelan Falls. Chief 701 arrived and reported a fully involved vehicle with no exposures. Rescue 71 arrived and extinguished the fire. Tender 71 arrived to provide water support. Cause of the fire was from a transsmission failure.

Motorcycle Accident 09/15/2014 around 1515 hours: 703, Engine 71 and Medic 3171 responded to a report of a motorcycle vs vehicle accident north of the tunnel on SR97A. Occupants of the vehicle were not hurt and the motorcycle rider was back boarded and transported to Lake Chelan Community Hospital in stable condition.

Motorcycle Accident 09/07/2014 around 1659 hours: Chief 701, Rescue 71, Medic 3171 responded to a report of a motorcycle vs. car accident at 3875 SR-97A in front of the Tsillan Cellars. Rescue 71 arrived on scene to find a motor bike and rider up-right on the side of the road. A vehicle had pulled out in front of the bike rider and he laid it down to avoid a collision. The bike suffered minor damage and the rider was evaluated and released on the scene.

Brush Fire 09/05/2014 around 2210 hours: Chief 701, Rescue 71, Tender 71 responded to a brush fire near Karma Kanyon Winery. Chief 701 arrived in the area with the fire visible from South Lakeshore Road behind Karma Kanyon Winery. Chief 701 reported a 50' x 100' brush fire on the hill side in light to medium fuels confined between the road and the orchard with possible spotting, responding units could handle it. The fire was burning along a fence line on the road and moving down a steep hill side. Recuse 71 and Tender 71 arrived and positioned on the road above the fire and quickly contained the fire with a wet line and then knocked down and extinguished the rest of the fire. The two units mopped up the fire area and hot spots. CAUSE: The discharge of fireworks had ignited the brush at the base of the fence post and the light winds spread the fire along the fence line and down hill towards the orchard.

House Fire, 09/02/2014, around 1649 hours: Chelan Fire and Rescue units Engine 71, 72, 73, Tender 71, Captain 703, Chief 701, Support 71 with a total of 16 personnel along with Medic 3171 and Chelan County Deputies responded to a residential house fire at 918 Parkview Drive around 1654 hours. Upon arrival, units found a 25 x 75 foot, two story, wood frame, single family residential structure with fire on the deck of the house extending into the kitchen and living room area of the structure. The initial interior attack team was able to knock down the fire and bring it under control within 10 minutes of arrival on scene. Primary and Secondary searches were conducted to confirm all occupants were out of the house. The home was occupied by the owner and her son who were home at the time of the fire. The owner was treated and transported to Lake Chelan Community Hospital for minor burns she received when attempting to fight the fire. The extent of damage is confined to the exterior wall adjacent to the kitchen and smoke and heat damage to the main floor of the house. Cause of the fire is under investigation.
