Funding:

- Annual increase 1% and new construction equate to about:
 - 1% 2019 = \$19,922.36 annually
 - New Construction 20019 = \$42,344.34

 - 2006 Passed \$1,50 per \$1,000
 - 2012 failed at \$00.18 per \$1,000 increase
 - 2018 failed at \$00.40 per \$1,000 increase
 - 2019 Current rate per \$1,000 is \$00.88
