Lt. Shawn Sherman reported that the total responses for 2019 was 888 calls, 130 of those calls were overlapping. Lt. Sherman also reported on significant calls for the 2019 year. Lt. Sherman handed the commissioners a copy of public relations events that the duty crew fulfilled during the year.

LT Sherman reported that Assistant Chief Asher has been working on completing the SAFER Grant 4th quarter report. And we have 3 new recruit firefighter applicants in new hire process.
