Chairman Moller announced the Flag Salute and opened the meeting at 15:00.

Approve Agenda: The agenda was APPROVED as submitted the MOTION CARRIED.

Consent Agenda: The consent agenda was APPROVED as submitted the MOTION CARRIED.

Fire Chief Report:

- Chief Donnell reported January financials are on target, that staff is watching expenditures, and we are working with sufficient carry over funds.
- Chief Donnell reported the annexation process was not completed. Assessor Deanna
 Walter and Deputy Assessor Skip Moore informed us that one of the required documents
 was misplaced. We have sent the requested documents and were informed this will not
 impact the budget or collection. Assessor Deanna Walters was apologetic and stated that
 she will complete the annexation process.
- Chief Donnell reported the Assistance Firefighter Grant (AFG) opened and will close middle of March. We are looking to submit for two urban interface engines, Chelan County Fire District 8(Entiat) is interested in participating in the grant to ensure a regional approach. The grant has a one-million-dollar cap, both departments have aging apparatus applying regionally will give us strength within the grant. Chief Donnell will meet with Fire Chief Mike Asher to get the ball rolling. The grant is a 5-15% cost share. We will spec out the apparatus, we already have equipment to complement the truck. The cost share estimate is \$40,000 which would be split between the two departments. If we are awarded the grant this would not impact the budget as we would use capital apparatus fund already budgeted.
- Chief Donnell reported 2020 operational goals; LRP staffing, apparatus, and facilities.
 January emergency call volume was 55 with 3 significant calls; electrical at Chelan
 Shores. One firefighter was injured and has fully recovered from head exposed and
 received stitches. Sprinkler activation at Grandview; extinguished the fire but lots of
 water damage.

The call comparison is at average.

January EMS breakdown 38 calls of service; 10 ALS, 15 BLS and 13 non transport. Chief reviewed the December average turnout times reporting a 3:31 minute average. Effective work force – was reported by incident type showing how many people responded to the emergency scene.

Pre-Fire Value vs Fire Loss information comes from the assessor office showing the losses and saved dollar amounts.

- Chief Reported that C-702 was repaired and is back in service, the cost was \$800.
- Chief Donnell reported; Station 71 crew quarter floor project is moving forward, Station 73 air compressor needs repaired, Mechanic Goyne is working on it. Station 75 bids to replace heaters is moving forward.
- Chief Donnell reported on the membership required participation and qualification stats.

Assistant Chief Report:

- Chief Asher reported the recruit academy is underway 20 recruits are participating and the class is a regional effort; we have 6 enrolled, Chelan County Fire District 1, 5 & 8 and Douglas County Fire District 2 & 4 those recruits make up the rest of the academy.
- Chief Asher reported the stipend program this last month was low on membership participation. We do have a few members signing up in the month of March. Next month the one stipend position is at 30% coverage of the shifts offered.
- Chief Asher has been working on the Blue Card Command level training the training is for incident command development.
- Chief Asher reported the current training focus is a refresher of EVIP.

<u>Firefighters Association Report</u>: President Dan Crandall reported the members elected new treasurer Jeanne Giddings, Secretary Anne Clark to the board.

President Crandall reported a balance of \$53,000 in the checkbook. A \$1,000 donation was given to the accident victim from last month incident. The Chelan High School shop class is building a shed to house the chairs and tables. The shed will be placed at station 71 the cost to build and deliver the shed is \$3,000. The association received two thank you notes for donations; Chelan Valley Thrive and WSC burn foundation in memory of Chief Johnson of Okanogan.

New Business:

Approval for Out of State Travel – Lt. Sherman to Water Rescue Instructor Course (Bangor, Maine)

• Chief Donnell reported out of state training would need to be approved by the board. The cost to send LT Sherman is estimated at \$3,600.

Commissioner Jones MOTIONED to APPROVE out of state travel for LT Sherman to attend water rescue training the MOTION CARRIED.

Resolution 2020-01, Single Source Approval:

• Chief Donnell reported the heating unit at station 74 is antiquated and a sole source distributor is required to purchase parts.

A MOTION to APPROVE Resolution 2020-01 Single Source was APPROVED the MOTION CARRIED.

Seasonal Firefighter/EMT Proposal:

- Chief Donnell reviewed the proposal for seasonal FF/EMT and explained why we use the positions and the history behind seasonal employees.
- Adding 2 or 3 seasonal 40 work week will cover the bulk of the work period giving a 3rd FF/EMT. Chief Donnell stated this is a band aid approach to a bigger problem in the future.
- Participation from Volunteers has been non-existent. The stipend position isn't getting filled and the program is not working like we would like it to.
- Chief Donnell explained the pay grade of the stipend shift and its not to exceed \$14,000 annually.
- Currently we budgeted \$141,000 that includes volunteer stipends and the stipend shift program. The seasonal positions can be included in the budgeted amount of \$141,000.
- Chief Donnell discussed the qualifications and benefits of medical only for the seasonal position.
- Chief Donnell would like to start the seasonal positions April 1 and end September 30, 2020 with a possible extension due to a longer fire season.
- Chief Donnell reported 3 seasonal position would cost \$76,000 and 2 would cost \$50,000 this would still allow one volunteer stipend shift every day. This is not a long-term fix. We do have interest from within if this would be approved.

Commissioner Moller would like to table the approval until LRP. Commissioner Moller would like to know how this will affect the budget through 2022. We are spending that money know when we might need it in the years coming. What if we don't pass lid lift? We could bank the money for the future budget. Should we be planning better to save know.

Chief Donnell stated \$50,000 would be well spent and allows us to provide the vital service we are responsible for. We have the funds; it is budgeted and it will be spent wisely.

Chief Donnell stated hiring two seasonal positions would cost \$36,000.

MOTION to hire 2 Seasonal EMT/FF starting May 1, 2020 ending September with an approval of the board for an extension if needed the MOTION CARRIED.
