**CLOSING DATE:** March 31, 2021

**WAGES:** \$16.50 to \$20.25 per hour depending upon qualifications. Medical, dental, and vision insurance included. No other paid benefits.

**OPEN TO:** All Chelan Fire and Rescue members that are in currently in good standing, have maintained required training, and meet the minimum qualification requirements at time of employment and/or as agreed to by the Fire Chief. This position may open to surrounding departments if internal applicant pool does not provide enough qualified applicants.

**NUMBER OF POSITIONS TO BE FILLED:** 2

**FLSA STATUS:** This position is an at will employment position assigned a 40-hour work week with possible after hour call back. The seasonal Firefighter position will start on May 1, 2021 and end on September 30, 2021. This position may be extended past the September 30<sup>th</sup> end date depending upon length of fire season and upon approval by the Board of Commissioners. This temporary (seasonal) full-time position is not covered under the Chelan Fire & Rescue/IAFF Local 4816 Bargaining Agreement.

**THE POSITION:** The Seasonal Firefighter position will supplement our current staffing during our seasonal uptake in call volume providing 3 Firefighters on shift daily. The Seasonal Firefighter work responsibilities include: responding to and dealing with emergency situations, natural conditions that pose a threat to life and property, and incidents of service to the citizens. Employees in this position are responsible for the protection of life and property through firefighting activities, emergency medical services, community risk reduction programs and other duties as outlined in the Firefighter/EMT Job Description.

**QUALIFICATIONS:**

- Current member in good standing with Chelan Fire & Rescue.
- Must possess a valid Washington State Driver’s License and EVIP card.
- Successful completion of Basic Firefighter Recruit Academy or completion of a fire service recruit training program approved by the Fire Chief.
- Red Card Certified, Wildland Firefighter Type 2 (Firefighter Type 1 preferred.)
- Current WA State EMT credential preferred but not required.
- IFSAC Firefighter I/II, Hazmat Operations preferred but not required.

**TO APPLY:** Send a cover letter stating your interest in the position along with a signed copy of the Firefighter/EMT Job Description. Copies of all required credentials must be on file with the Administrative Office Staff prior to the Candidate Interview date .
