#### Flag Salute

Roll Call: Karyl Oules and Russ Jones in person. Chairman Phill Moller was unable to attend meeting.

Regular Meeting Call to Order: Commissioner Jones called the meeting to order at 3:00 p.m.

Oath of Office: Chief Mark Donnell gave Commissioner Russ Jones the oath of office.

Approve Agenda: MOTION WAS MADE approve the agenda with the exception of moving the introduction of Lateral Firefighter after public comment, MOTION CARRIED.

#### Public Comment:

Larry Peabody: made comment on hiring of an assistant fire chief, it is a vital position and due to the work load this is a needed position. The public wants the commissioners to do the right thing, move forward with hiring an assistant fire chief.

#### Introduction of Lateral Firefighter new hire - Brandon Fogelson

Chief Donnell introduced Brandon Fogelson, Brandon is a 20-year veteran of the EMS service and has been a volunteer firefighter for the last 3 years, he also lives in Chelan. Thank you for the opportunity!

Chief Donnell recognized: Robert Takagi – 5-year pin. Marcia Holmdahl – 10-year pin Thank you for your service.

#### Fire Chief Report: (Chief Donnell)

- 2021 Budget & Financial Report (November 2021 Financials if available) Chief Donnell stated the November Financial where not completed by the County so the report will come next month.
- November Emergency Response Report:
- 74 November calls, our 10-year average is 60, we are over at 8.7%. EMS calls are at 67%.
- We are on track, coming close to 1000 calls we will break the 1000 mark by year end.
- EMS breakdown is at 37% with no transport.
- 2 technical rescue calls this November
- We have met the turn out and response time delivery goals.
- Fire loss for the month of November is at \$2,000.00 annual tax loss \$1.60
- Operations: we continue to have vaccination clinics and working with EMS
- FF Belsky completed the Assistant to Firefighter Grant; submitting for Diesel Exhaust removal system at \$165,000 for stations 71,73 and 75.





- Chief Donnell submitted year end personnel qualifications breakdown to the commissioners.
- Community Risk Reduction: Taylor Rains has completed 2 national academy pre-courses for Community Risk Reduction national course and will be attending the class in the spring.
- Apparatus Update: Mechanic Goyne has returned from Wisconsin from inspecting the ladder. Estimated
  costs will be around \$180,000 the apparatus will be fully refurbished. We expect the ladder to return in late
  spring.
- Brush 71 was surplused at \$26,000. Mechanic Goyne is working on Brush 73 (M1083) and the new Brush 71 should be completed in the next couple months.

<u>Firefighters Association Report</u> (Dan Crandall) Reported income of \$1,161.00 and 2- expenses; we donated \$1,161.00 to VFI and \$500 to Chelan Food Bank. Ending balance \$32,169.00.

New business: election of one officer, end of year Dan Crandall will retire and Ron Simmons was appointed the new president.

Santa Stars was fun! The Association of WA Businesses donated \$1,200 to our association we in turn donated it to Santa Stars. It was fun and the kids had a great time.

Quarterly \$500.00 donations to Chelan Food Bank was approved. Also approved \$500.00 donation to the Salvation Army kettle.

Commissioner Jones thanked Dan Crandall for his services to the membership.

#### **Unfinished Business:**

- Fire Chief Contract Board Approval: Chief Asher intentions is to be in place for 5 years the contract is the same as the prior fire chief contracts. Removed the 3% annual increase it was moved to negotiations and performance. The board agreed and will sign the contract as presented.
- 2022 Budget Board Approval
- Commissioner Oules noted she has received many calls regarding the extra funds. Commissioner Oules would like the funds to be shown in the budget.
- Chief Donnell explained the funds are shown and distributed into the apparatus replacement fund of \$590,000. The board has the ability to change the funds from apparatus replacement. We did have to increase the facility funding due to the replacement of station 71 roof at \$125,000. Ending balance of \$861,000 for 2023 carry over with \$166,000 of un committed funds at the end of the year.
- We can change the \$590,000 to \$250,000 in apparatus fund, this will leave us \$173,185 of uncommitted funds at the end of the year. We can put it into the reserve fund.
- We are confident that we will receive \$3,457,561 in property tax.
- Chief Donnell stated the budget is the best guess estimates. There are to many unknowns through the year
  to base the budget on, last year we had lots of firefighter overtime, due to firefighter injury and expanding
  families. Again, it's our best guess.
- Commissioner Oules would like to see a unique line item of the extra funds to satisfy people questioning the extra funds.
- Commissioner Jones suggested for tracking purposes we can establish a GL # to show the excess funds.
- Commissioner Oules stated there are people stating we will have a wind fall of \$400,000 to \$500,000, what happened to all of those funds?
- Chief Donnell state we added the extra funds into apparatus fund of \$250,000 and \$125,000 for station 71 roof. The rest of the funds \$173,185 are end of year uncommitted funds.
- Chief Donnell stated we can set up a GL# to show the \$173,185 for the end of the year uncommitted funds.
   We received funding twice a year; April and November we will not know the excess funds until the end of the year.
- The board will need to approve the budget at this meeting.
- MOTION was MADE to approve the 2022 budget, Commissioner Oules stated collectively will
  approve the budget as long as she sees in writing what she asked for. The MOTION CARRIED.
- Chief Donnell stated the line item will be added to the budget so that it can be seen.





- Assistant Fire Chief Position Direction from Board: Chief Donnell stated we made the recommendation and staff recommends getting the position filled. Chief Donnell sent options to the board as training captain or battalion. The battalion will need to be negotiated. Putting either of those positions into duty will cost the district more in overtime than the original assistant chief position. Staff would like direction from the board. Not filling the position doesn't change the work load, there will be work not done if we don't fill the position. If not done, this will be an in justices to the district. We don't want to eliminate the position this does not make any sense.
- · Commissioner Oules would like to table to discussion until Phil Moller is in attendance of a meeting.
- Commissioner Jones stated the position is in the budget and has been. Commissioner Jones is not sure of
  the objection Commissioner Oules has. If we don't fill the position, we will pay more in overtime with
  filling the position with duty officers. Commissioner Jones would like to see us move forward.
- Chief Donnell stated he has agreed to stay on and help with weekend duty. But this will end in March.
- A Special Meeting was scheduled for Wednesday December 22, 2021 at 3:00 p.m. to discuss hiring of an Assistant Fire Chief.
- 2021/2022 Annexations Update: Chief Donnell and Chief Asher met with the Assessor last week. Chelan Falls residents will receive refunds of 3 years' worth. The total amount is \$36,000 that will be removed from our revenues to pay back the residents. The refunds may be paid back to us in 2023. We sent annexation letters to the 21 Chelan Falls residents and they will need to sign the petition and we will take care of the rest. We have a couple annexations that didn't make the cut from 2021. We will submit all annexations this year. We will not charge those residents if we need to respond to an incident while we are waiting for annexation completion.
- City of Chelan Fire Protection Services Contract Update Chief Donnell and Chief Asher met with the
  City and the agreement has gone to our attorney. No money will be exchanged and the agreement identifies
  who is responsible for what. This was a long process and gives us a great starting point, you can always
  make concessions as the years progress.
- Station 75 Short Plat Update Chief Donnell touched base with Morgan Picton and he will continue to process.
- Feasibility Study Letter Chelan County Fire District 5 and Lake Chelan EMS Update: Chief
  Donnell stated the hospital board member sent a letter to the board and an invited them to a hospital board
  meeting.
- Commissioner Oules spoke with Rinita Cook who offered to sit down with the board and talk about all of
  the legalities involved with EMS. The other thing that I need, because people ask me; why do we go out on
  every EMS call? Commissioner Oules found we have a contract; we have certain verification requirements
  and WAC's that covers us a fire district that we need to be doing. I want to contact those people to tell them
  why we do it.
- We have not heard anything from Chelan County Fire District 5.


