Regular Meeting Call to Order: Chairman Moller called the meeting to order at 15:00

# Fire Chief Report: (Chief Asher)

2023 Budget & Financials:

• September financials are coming in under budget. Well, within appropriate numbers.

# **Emergency Response Reports:**

- The September Incident Response Report shows 92 calls for emergency service, with our 10-year average call volume for September at 80 calls. 2<sup>nd</sup> busiest September.
- Rescue/EMS responses accounted for 74% of total calls for service, with 30% of that nontransport (including patients who died at the scene) or patient transported POV, which is a bit higher than normal.
- Major incidents for September: See PPT
- September turnout and response times (primary apparatus at Station 71) are within established service delivery goals as set out in SOG 010.
- Effective Work Force: Effective workforce was acceptable for call types.
- Total fire loss for September is 0

#### Administration:





- ESO migration is ongoing. We are now watching the administration set-up videos, making sure things are correct, and then we'll allow the crews to log on.
- TIF—We had a good meeting with the city in regard to TIF and a per-call proposal for mitigation. The City is making a counter proposal that we will have a legal review. The city has a meeting on October 24<sup>th</sup>, so I'm hoping to be able to counter their proposal before then.
- We're starting the planning for our end-of-year social. December 12, 2023.
- Doug Jones is the new Rivercom Director, replacing Lowel Porter, who has retired. Lowel has improved Rivercom tremendously since I've been here, and Doug looks forward to continuing his success.
- Chief Asher, Chief Sherman, and Barry Leahy attended the memorial for Captain Ron Roy, who served 50 years for the Wenatchee Valley Fire Department and was a massive advocate for volunteers. Ron's motto: Doing it for free since 73.
- Chief Asher made a post about WSRB on Facebook, which has created savings for our community. It has also given us the opportunity to answer questions, sell our message, and hopefully assist in recruitment.
- Commissioner Jones, Chief Asher, and Mark Donnell will attend the Commissioner's conference next week.
- Commissioner Moller thought we decided to stop inviting the candidates!

#### **Operations:**

- Mechanic Miller has completed both of his training conferences to obtain some EVT certifications.
- Our regional hazmat team is attempting to get another \$250,000 grant to increase our capabilities regionally. We're currently going through equipment requests and needs.
- Tried a mobile booster for the internet, and it didn't work. It only works in line with the site, and our area has issues.
- This is the last week that our seasonals are working. I can't thank them enough for the flexibility they bring to our organization. The ability to have more firefighters on shift, mobilize for state incidents, and fill in while we have injured firefighters.
- FF Stodghill has a conditional job offer with Renton Fire Authority. He plans to work stipend shifts until his hire date.
- Volunteer Point Example: Chief Sherman
- Chief Sherman showed a slide with 2022-point totals with point values and a proposed new value for 2024. It is not a huge difference. If approved, this would be a 20% increase in the point value.
- Chief Sherman showed other scenarios and costs.
- We can improve the incentive program to make it more palatable for the volunteers.
- Commissioner Moller: It's a good start, and I appreciate it. Hopefully, we can make this a working program.
- Chief Asher the incentive is built into the 2024 budget.

# **Community Risk Reduction/Events:**





• It was Fire Prevention Week, October 9-13. Karla did a great job of using our LED sign with preprogrammed fire safety messages.

# **Apparatus Status:**

- The fire capabilities of the boat are still a work in progress. We have the parts needed to install.
- The L71 turntable turns slowly to the right. We are going to swap hydraulic control manifolds with Entiat to save \$12,000 on that part. Mechanic Miller will be getting this scheduled.
- B71 2020 Dodge Ram has been sold to the City of Chehalis for \$110,000.
- The type 3 brush truck is still going through its refurbishment. We're hoping for the final last week of November. Brindlee will pay for inspection and shipping.
- The update on the Spartan engine should be doing the final inspection on January 29<sup>th</sup>. The second engine should be finalized at the end of February. Spartan will pay for the \$18,000 in shipping for both rigs.
- We are evaluating what we should sell E73. Comparing it on the Brindlee site, it seems we should ask \$25,000 to \$40,000. This seems high. But the truck is in great shape with only 18,188 miles. The engine is a 1996. It is past years of service by WSRB.
- R71 tank has arrived and will be a winter project.

# Stations:

- Station 71 generator update. Still no return call from any electricians. We have reached out to 3 separate ones.
- The Station 71 Design team has been created and we had our first meeting. We will be applying for architectural funding 2<sup>nd</sup> week of January 2024. We will have funds by July if successful. We will then apply for construction funding 2<sup>nd</sup> week of January 2025.
- Station 74 Lease. 20 years ends on 12/31/2041. We pay \$2,739 annually. The agreement is negotiated every five years. CPI can happen annually.
- Station 74 we'll have to do an RFQ because it's over \$50,000. The overall project \$100,000 just for HVAC. Our cost will be from \$30,000-\$40,000.
- Chief Asher recommends the board approve and the \$40,000 budgeted in capital 2024 expenses.

# Assistant Fire Chief Report (Asst. Chief Sherman)

- Volunteer Recruitment / Training
- One application in the process the person is interested in PIO and social media.
- 2024 planning meeting for FF academy meeting with other agencies to find out how many will be in attendance and training aspects. Direct pay from WA State Patrol to teach the classes.
- Mark Donnell and John Steiner are the only ones participating in the stipend program.
- A couple of the Seasonal Firefighters are interested in the stipend program.
- Bob Wentland Thank you for teaching the last three drill nights. THANK YOU!
